1.01 - 1.04 The provisions are for Secretariat expenditure of the Departments as also for the Appellate Tribunal for Foreign Exchange.

1.05 The provision is for Secretariat expenditure in respect of Official Languages Wing responsible for translation of and printing of Central Acts into Hindi and other Regional Languages as well as for the Unified Litigation Agency which is responsible for conduct of cases in the Supreme Court on behalf of the Central and the State Governments participating in the Scheme of the Central Agency.

2.01 The provision is for meeting the carry forward liability in respect of General Elections to the 14th Lok Sabha.

2.02 The provision is for reimbursement of Central Government's share on election expenditure to the State/UT Governments. It also includes the cost of preparation and printing of electoral rolls etc.

2.03 The provision is for reimbursement of Central Government's share to State/U.T. Governments on issuance of Photo Identity Cards to voters.

3.01 The Income Tax Appellate Tribunal has been set up under the provisions of the Income Tax Act, 1961 to hear appeals against the decisions and orders of the Chief Commissioners of Income Tax, Directors General of Income Tax, Commissioners of Income Tax, Commissioners of Income Tax (Appeals) and Deputy Commissioners of Income Tax (Appeals).

3.02 The National Tax Tribunal has been set-up for the adjudication of disputes with respect to levy, assessment, collection and enforcement of direct taxes and also to provide for adjudication of disputes with respect to the rates of duties of Customs and Central Excise on goods and the valuation of goods for the purposes of assessment of such duties as well as in matters relating to levy of tax on service.

4.01 The National Judicial Academy was set up as a registered society with effect from August 17, 1993. The provision is mainly for functioning of the said Academy and implementation of UNDP Project by them.

4.02 The provision is for expenditure on computerisation of District and Subordinate Courts.

4.03 The provision is made for the running expenditure of Family Courts in States/Union Territories.

4.04 The provision is for recurring and non recurring expenditure of 1562 Fast Track Courts (continued beyond 31.03.2005).

4.06 The provision is for providing assistance to U.Ts without Legislatures for infrastructure facilities for Judiciary.

4.07 The provision is for Law Officers, Legal Advisers and Counsels and also for Legal aid to the poor through NALSA.

5.01 The provision is for Centrally Sponsored Scheme for development of infrastructural facilities for the Judiciary.

5.02 The provision is for providing grant/assistance to Union Territories with Legislature for infrastructure facility for Judiciary.

5.03 The provision is for Law Commission, International Law Association and for publication of Law Books and Journals in Hindi by Vidhi Sahitya Prakashan.

5.04 The provision is for acquisition of land and construction of buildings for Institute of Legislative Drafting and Research, various Benches of the Income Tax Appellate Tribunal and the National Tax Tribunal.

6 The provision is for projects/schemes for the benefit of the North-Eastern Region and Sikkim.
